THE FEI CODE OF CONDUCT FOR THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stage during the preparation and training of competition horse, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, side safety and horse fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest level of education in their areas expertise.

KODE ETIK UNTUK KESEJAHTERAAN KUDA

Fédération Equestre Internationale (FEI) mengharapkan semua yang terlibat dalam olahraga berkuda diseluruh dunia untuk mematuhi Kode Etik FEI dan untuk mengakui dan menerima bahwa setiap saat kesejahteraan kuda harus menjadi yang terpenting dan tidak boleh disubordinasikan atas pengaruh persaingan/ pertandingan maupun komersial.

- 1. Pada semua tahap selama persiapan dan pelatihan kuda kompetisi, kesejahteraan harus didahulukan dari semua tuntutan lainnya. Ini termasuk penerapan tata cara pemeliharaan kuda yang baik, baik metode pelatihan, penapalan, perlengkapan dan transportasi.*
- 2. Kuda dan atlit yg akan bertanding harus dalam keadaan sehat, memiliki kemampuan dan kesehatan yang bagus sebelum diizinkan untuk bersaing. Ini juga meliputi penggunaan obat-obatan, prosedur bedah yang mengancam kesejahteraan atau keselamatan, kehamilan, dan penyalahgunaan alat bantu.*
- 3. Semua kegiatan harus tidak boleh mengesampingkan kesejahteraan kuda. Ini meliputi pertimbangan yang cermat atas arena pertandingan, permukaan yang rata, kondisi cuaca, masalah kandang, faktor keselamatan dan kesehatan kuda untuk melakukan perjalanan selanjutnya setelah acara.*
- 4. Segala upaya harus dilakukan untuk memastikan bahwa kuda mendapat perhatian yang tepat setelah mereka berkompetisi dan bahwa mereka diperlakukan secara manusiawi ketika masih dapat berkompetisi maupun setelah afkir. Ini mencakup perawatan hewan yang tepat, cedera kompetisi, eutanasia, dan pensiun.*
- 5. FEI menghimbau semua yang terlibat dalam olahraga ini untuk meraih Tingkat pengetahuan tertinggi dalam bidang keahliannya.*

➤ ENTRY FEE

- a. Entry fees of the classes are stated on the Schedule of Classes:

The Categories of age of athletes / Kategori Umur atlit:

- **U16**
Age of athlete up to 16 year old in 2025 (born in 2009 and after)
Umur atlit sampai dengan 16 tahun di tahun 2025 (lahir 2009 dan setelahnya).
- **U18**
Age of athlete up to 18 year old in 2025 (born in 2007 and after)
Umur atlit sampai dengan 18 tahun di tahun 2025 (lahir 2007 dan setelahnya).
- **U21**
Age of athlete up to 21 year old in 2025 (born in 2004 and after)
Umur atlit sampai dengan 21 tahun di tahun 2025 (lahir 2004 dan setelahnya).
- **New Comer Rider**
Riders who never joined in any competition.

- **Open**
Open to athletes all aged.
Terbuka untuk semua umur atlit.

3. HORSE/KUDA

- a. A horse may compete maximum of three classes at the same day, with same or different rider in Jumping Classes with highest of fence 90 cm or Preliminary FEI.
Setiap kuda dapat mengikuti maksimal 3 kelas pertandingan di hari yang sama dengan atlit yang sama atau berbeda pada kelas Jumping dengan ketinggian mulai 90cm atau kelas preliminary FEI.
- b. Horse Number: Horse Numbers are not distributed by the organizing committee. Riders must provide horse number and they are responsible for displaying the correct number on their horses at all time.
Panitia tidak menyediakan nomor kuda. Atlit harus menyediakan sendiri nomor kuda dan bertanggung jawab atas pemasangan nomor kuda dan dipasang dengan benar pada saat event berlangsung.
- c. Young Horse class :
 - 3 y.o born in 2022

4. STABLING/KANDANG

➤ **STABLING FEES/ BIAYA SEWA KANDANG :**

- a. Temporary Stable 3x3 m (Knock down, Roders tent), Daily : Rp. 450,000,-
- b. Permanent stable 3x3 m : 550.000,- (Limited Slot)

- Stable boxes will be allocated to whoever has done the payment of their booking stable. (Booking of stabling will be approved after payment have been done).

- Only **STANDING FANS** are allowed to be used in the stable! (No wall-mounted fans are allowed).

5. STABLING POLICY / Ketentuan tentang kandang:

- a. Stable opens on Monday, 01 September 2025. Number of the day counting starts from the day of arrival. The starting (changing) of the day is counted from 00:00
Kandang dibuka pada hari Senin, 01 September 2025. Jumlah hari stabling terhitung sejak hari kedatangan. Perubahan hari dimulai pada jam 00:00.
- b. Permanent Stables are available with very limited number, therefore they are priority will be allocated to the naughty stallion horses.
Ketersediaan kandang Permanen sangat terbatas, oleh karena itu prioritas utama kandang permanen untuk kuda - kuda jantan yang nakal.
- c. The Temporary Stable will be covered by Roders Tent. TYPE A will complete with aircondition inside of the tent.
Kadang Tipe A akan menggunakan atap tenda Roders dengan pendingin udara didalam tenda.

- d. Cooking / using the cooking device (rice cooker, water heater etc) in the stable is FORBIDDEN.
Memasak / menggunakan peralatan memasak (memasak nasi , memanaskan air) di dalam kandang DILARANG.
- e. Burning any material in the stable is FORBIDDEN.
DILARANG membakar apapun di dalam kandang.
- f. Must keep CLEAN all the time at Stable, Rubbish and The Dung must be removed EVERY DAY. When CHECK-OUT before leaving, the stable MUST BE BACK TO CLEAN.
Kandang harus selalu dalam keadaan bersih, SAMPAH dan KOTORAN KUDA harus diangkat setiap hari dan pada saat CEK-OUT meninggalkan kandang juga harus dalam keadaan BERSIH KEMBALI.
- g. Violation of the STABLE CLEANLINESS REGULATION subject to fine (50K/person). Bill to the club concerned.
Pelanggaran terhadap PERATURAN KEBERSIHAN KANDANG akan didenda (50K/orang). Tagihan ke Klub yang bersangkutan.

7. TECHNICAL INFORMATION / INFORMASI TEKNIS

The Classes will be judged under:

A. TABLE A

Faults are penalised in Penalty points or by Elimination according to the tables set out in this Chapter :

B. NORMAL TWO PHASE

- Competition comprises two phases run without interruption, each at an identical or different speed, the finishing line for the first phase being identical with the starting line for the second phase.
- The first phase is a course of seven to nine obstacles with or without combinations. The second phase takes place over four to six obstacles, which may include one combination.
- Athletes penalised in the first phase are halted by ringing the bell after they have jumped the last obstacle or when the time allowed for the first phase has been exceeded, after crossing the finishing line of the first phase. They must stop after crossing the first finishing line
- Athletes not penalised in the first phase continue the course, which finishes, after crossing the second finishing line.

C. OPTIMUM TIME

Classification of Winner/ Klasifikasi Pemenang:

The Winner of the round is the athletes & horse combination with the lowest penalty. In the event of equality the classification is decided in favour of the athlete who got the closest time to the optimum time. The safe zone of optimum time is 3 second below and above of the optimum time.

Pemenang untuk masing-masing putaran ditentukan dari pasangan atlet dan kuda yang memiliki kesalahan terkecil. Jika terdapat kesamaan kesalahan maka pemenangnya ditentukan berdasarkan perhitungan waktu yang paling mendekati dengan waktu optimum dan yang memiliki selisih waktu optimum yang paling kecil. Zona aman dari waktu optimum ditetapkan 3 detik dibawah dan di atas waktu optimum.

D. FEI Art. 269 ACCUMULATOR;

- a. This Competition takes place over six, eight or ten obstacles with increasing difficulty. Combination obstacles are not allowed. The increasing difficulty is not solely due to the height and spread of the obstacles, but also to the difficulty of the track.
Kompetisi ini berlangsung dengan 6, 8 atau 10 rintangan dengan tingkat kesulitan yang semakin meningkat. Rintangan kombinasi tidak diperbolehkan. Meningkatkannya kesulitan bukan karena tingginya atau karena lebar rintangan tetapi juga bisa oleh sulitnya lintasan.
- b. Bonus points are awarded as follows: one point for obstacle number one not knocked down, two points for number two, three points for number three, etc. with a total of 21, 36 or 55 points. No point is awarded for an obstacle knocked down. Faults other than knock-downs are penalized as for Table A.
Bonus poin akan diberikan dengan perhitungan sebagai berikut: 1 poin untuk rintangan nomor 1 jika tidak dijatuhkan, 2 poin untuk rintangan nomor 2, 3 poin untuk rintangan nomor 3 dst., dengan total maksimal poin 21,36 atau 55 poin. Poin tidak akan diberikan untuk rintangan yang dijatuhkan. Kesalahan karena menjatuhkan rintangan akan dihitung berdasarkan Table A.
- c. For the last obstacle of the course, an alternative obstacle may be provided, of which one element may be designated the Joker. The Joker must be more difficult than the alternative obstacle and carry double points. If the Joker is knocked down, these points must be deducted from the total points obtained so far by the Athlete.
Pada rintangan terakhir akan disediakan alternatif rintangan yang disebut Joker. Rintangan Joker harus memiliki tingkat kesulitan yang lebih tinggi dengan nilai poin ganda. Jika Joker dijatuhkan maka poin Joker akan mengurangi jumlah poin yang telah dikumpulkan.
- d. The qualification of winner is the combination who got the highest point and the fastest time.
Kualifikasi pemenangnya adalah kombinasi yang memiliki point paling banyak dengan waktu tercepat.

E. Art. 273.3.2 (Competition Over Two Round with jump off)

- a. This Competition comprises, with the same speed, two courses, identical or different, either in track or in number of obstacles or in the dimensions of the obstacles. Each Athlete must participate with the same Horse. Athletes, who have been eliminated or who have retired during the first round, may not take part in the second round and may not be placed.
Ini merupakan pertandingan yang terdiri dari putaran dengan kecepatan yang sama dari dua course (bisa identik atau berbeda) baik lintasan, jumlah rintangan atau dimensinya. Harus menggunakan kuda. Bagi yang tersisih di putaran pertama tidak dapat mengikuti putaran ke dua.
- b. First round not againsts the clock, second round againsts the clock. Athlete with equality of penalty after 2 round may be jump-off.
Putaran pertama tidak memperhitungkan waktu, putaran kedua juga tidak memperhitungkan waktu. Atlet dengan total kesalahan sama setelah 2 putaran akan dilakukan jump-off.
- c. Starting order second round Reverse order of penalties in the 1st round; Athletes retain their drawn order in case of equality of penalties.

If a rider damages an obstacle during practice / competition, they are responsible for **Rp. 750.000** damage fee per item of obstacles.

9. TECHNICAL MEETING

Technical meeting is carried out to notify important information concerning the event. It is mandatory for all participant, horse owners and coaches to attend the technical meeting carried out by the event organizing committee.

They are therefore strongly advised to take out third party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep their policy up to date.

If the complaint is accepted OC will refund the deposit conversely, if the complaint is not accepted the deposit will remain with the OC. Refer to the FEI Art. 167 Of General Rules & regulations for more details.
